CERTIFICATE OF RECOGNITION

DISTRICT EDUCATION OFFICER (E.E) GURDASPUR PB.

(Name and Address of the issuing Authority)

1. It is certified that The Salvation Army School, Batala , Distt. Gurdaspur. PB. Is a private unaided school. Our School has been granted provisional recognition under RTE Act 2009, Section 18, and Punjab RTE Rules 2011 (11) sub-rule 4, for classes I to VIII, valid from April 1, 2020 to March 31, 2023, as per the District Education Officer (E.E), Gurdaspur's letter NO. R.T.E/2020/3095, dated 26-08-2020. A photocopy of the recognition letter is enclosed.
2. On April 12, 2023, the High Court of Punjab and Haryana at Chandigarh given decision on Civil Write Petition No. CWP-7238-2023, filed by the Federation of Private Schools and Associations of Punjab against the State of Punjab and others. The court ruled that permanent recognition shall be granted to private schools, as per the provisions of the Right of Children to Free and Compulsory Education Act, 2009.
3. Government of Punjab Education Department, Education -3 Branch, vide para 2 of their letter No. 1/732379/2023, dated 29-11-2023, has directed that Private Schools issued with temporary recognition under the RTE Act 2009 and Punjab RTE Rules 2011 shall be treated as having permanent recognition. A photocopy of the relevant document is enclosed for reference.
4. Keeping in view the said facts, our school has been granted permanent recognition under the RTE Act 2009 and Punjab Rules 2011, with effect from the date of the decision on civil Writ Petition No. CWP-7238-2023, i.e., 12th April 2023.
